- 1) Diversity of students- It was found that department admitted students from specific geographic cluster only in OHU category. Hence, efforts were made to increase heterogeneity within batch. Accordingly, required promotional efforts were to attract students from erstwhile untapped areas.

- Faculty will be motivated for research by attending more relevant workshops and STTPs.
- Campus placement of students is less cause majority of the students failed to satisfy the criteria of having throughout first class. Most students coming to MCA have a low score in the 12<sup>th</sup> standard. But off campus placements are good and all the students are placed well.
- Also, other than syllabus sessions for technical and general aptitude were part of the syllabus
- Also , trainings from spoken tutorial on various technologies are part of the regular Time Table.
- The time table also includes an additional soft skills session

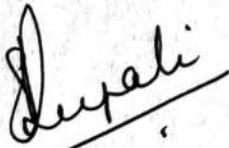

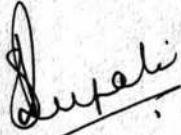
